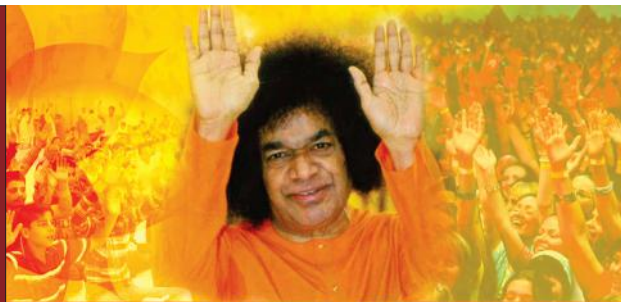

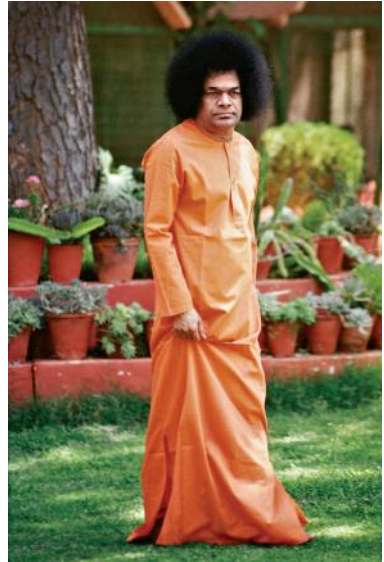

**Report of the Trustees**

for the period April 1, 2014 to March 31, 2015.

This year is a special one for all members of the Sai fraternity as it marks the 90th Birthday of Bhagavan Sri Sathya Sai Baba. It is also 4 years since Bhagavan left his physical form and left the task of administration and care of the Trust to the Board of Trustees. The latter have also gained confidence in the task entrusted to them.

The Sathya Sai Central Trust is a unique one. It is not a religious trust but one whose objectives comprise service to the needy through activities in the fields of Health, Education and Public Utility. Bhagavan has set up landmark Institutions and Projects with very innovative models of efficient functioning. The attention of the Trustees has been to ensure that these work in the same efficient manner in the continuing spirit of inspiration and dedication as well as to provide them the latest and modern tools to do so.

The Trust continues to be one of the few submitting an Annual Report, which is also put in the public domain through our website.

Some of the important happenings during the year were:

- Several Ministers of the Union and State Governments visited Prasanthi Nilayam during the year.
- The Board of Trustees held 6 meetings during the year under review; The Board of Management held 7 meetings. Some of these meetings were held at the Brindavan complex of the Trust near Bangalore.
- All statutory reports to the Central and State Government were submitted in time.
- The Prashanthigram Hospital commissioned a new 128 slice CT scan, which also provides the best resolution for cardiac scans. Other equipment included New Echo Machines for Cardiology and CTVS, new Central Sterilisation Unit as well as Laundry. Further upgradation was done of the air conditioning systems in the surgical and treatment areas to reduce risk of infection. A new modular operation theatre was commissioned in the CTVS accompanied by upgradation of the ICU. A new High Dependency Unit was set up for non cardiac cases.

Additional staff quarters were also constructed.

The Whitefield Hospital has been implementing the Minimal Access Cardiac Surgery Programme started last year and has done over 100 cases. Good use was made of the MRI, the Biplane Cathlab and the Neuro Navigation facilities. The Nursing College at the Hospital, which is affiliated to the Rajiv Gandhi University of Medical Sciences, continued its good work. Students fared very well in the University examinations. Several innovative programmes were also conducted by the College.

The expansion of the General Hospital at Puttaparthi was completed and inaugurated in October 2015.

The Mobile Hospital continued its track record of excellent service in the villages surrounding Puttaparthi. A new Mobile Hospital has just completed one year of service in the environs of Chennai in Tamil Nadu and has been awarded the A.P.J. Abdul Kalam award for Excellence in Health Care; the award has been instituted by a leading private organisation in that state.

All the hospitals conducted varied technical conferences and their faculties submitted many papers in leading professional Journals.

- The inauguration of the extension to the Rural Drinking Water Supply Project to an additional 118 habitations in Anantapur District was done on November 23, 2014. In addition, about Rs 5 crores was spent on extension of water supply to Puttaparthi Municipality. The Trust also participated in the NTR Sujala Padhakam programme of the Andhra Pradesh Government.
- The construction of the Sri Sathya Sai Centre for Advanced Studies and the new hostel for students at the Muddenahalli Campus are nearing completion.
- The Sri Sathya Sai Institute of Higher Learning continued its progress on all fronts. Consequent to the completion of the term of the previous Vice-Chancellor, Prof. K.B.R. Verma, distinguished



scientist from the Indian Institute of Science, Bangalore, was appointed as Vice- Chancellor by the Chancellor, Justice M.N. Venkatachaliah.

MBA programme for women students was introduced at the Anantapur Campus in June. The Masters in Computer Applications MCA programme for men students was also commenced.

In addition to the over 90% of pass rates in all university examinations, 38% of eligible students were successful in the national examinations of GATE, JUST and 7% in UGC-CSIR Net.

The teaching faculty continue to win awards, distinctions and deliver keynotes in reputable academic conferences across the country. These include Paper & Poster Presentations, Keynote addresses at National and International Conferences, Invited talks and lectures in workshops and seminars and guest lectures at various academic events around the country.

Grama Seva was conducted in over 100 villages in the three mandals in Anantapur District for 9 days. Clothes and food were distributed free and there was active participation from the students and staff of our educational institutions.

The Vidya Vahini Programme launched by the Founder Trustee continued to make good progress during the year. New Academic Content in the form of lesson plans were introduced. The unique nature of this programme is the participation of several thousand volunteers in all aspects of the programme.

The Sri Sathya Sai Seva Organisation in India and the Sri Sathya Sai International Organisation continue to expand their outreach into Society to render greater service to the poor and needy.

- The requisite financial information on the Trust is provided in the Annual Report. The Trustees are constantly monitoring the availability, use and investment of funds to maximise the resources of the Trust.

- All festivals and functions were observed and celebrated on schedule as in the earlier years.
- An elegant Archives building with multiple levels of climate and atmosphere control, has been constructed to house all the audio visual material connected with the Founder Trustee. These materials are all now in the process of being digitised to enable access to scholars for research.
- The anniversary of the Mahasamadhi of the Founder Trustee was observed with due solemnity on April 24. The students and staff from Sri Sathya Sai Educational Institutions offered a special musical programme of Kritis in the morning. This was followed by an eloquent speech by the noted Economic thinker Sri Swaminathan Gurumurthy, who extolled Bhagavan's contributions to Humanity.
- We gratefully acknowledge the continuous support and assistance that we have been receiving from the Governments of India, Andhra Pradesh and Karnataka.

Devotees from all over the world continue to pour into Prasanthi Nilayam. Many new faces and younger persons are now seen at Puttaparthi. It is such devotion, continuous commitment, support and assistance of the millions of devotees which inspire us.

We wish to place on record our appreciation of the committed service rendered by employees of the Trust, our associate organisations, the dedicated force of Seva Dal volunteers from all over India and the large number of our well wishers.

We, the Trustees, pray to Bhagavan Sri Sathya Sai Baba to make us fit instruments for the execution of His Divine Mission and continue to guide us in this task.

Increasingly bringing succour and relief to millions of the needy.

Sri Sathya Sai Central Trust

Based on the social philosophy of Baba, the Trust's initiatives have been successfully bringing analysis-driven Science closer to unifying Spirituality, efficiency-driven Institutions closer to eternal Human Values and comforts of Modernity closer to stability of Tradition.

The Trust undertakes numerous projects broadly classified under Medicare, Educare and Socicare, in identified areas, which are crying for attention. Keeping in mind the evolving needs of the poor and the less privileged, the Trust continually enlarges the reach of the projects to make them more extensive and at the same time brings more focus in to the activities to make them more intensive and exhaustive.

Medicare - Love that heals

Medical care for the poor and the needy has been one of the primary aims. Embodying a harmonious blend of the 'Philosophy of Healing' and the 'Science of Love', these activities encompass general and super speciality hospitals, which are being continuously expanded and upgraded. The Trust is constantly on the lookout for harnessing modern advances in science and medicine for the benefit of mankind. Telemedicine which enables remote consultation and diagnosis without a patient having to actually travel

to a hospital, is a much appreciated move in this direction. In addition, carrying forward Baba's desire that medical care should be provided at the very door step of the under privileged, fully equipped mobile hospitals have been commissioned. Operating in Andhra Pradesh and Tamilnadu, these vehicles are mini hospitals, with critical diagnostic equipment on board. As mandated by Baba, all these services are provided free of cost to the needy.

Educare - Love that inspires

Baba had often said that students are His only property and had accorded top priority to education. Sri Sathya Sai Institute of Higher Learning, the four-campus deemed university and hundreds of Sri Sathya Sai schools spread across and outside India offer the best in terms of quality of faculty, laboratory and library facilities, gymnasiums, auditoriums – all at no cost. The schools and colleges follow an integrated education system based on universal values of Sathya, Dharma, Shanti and Prema often equated to knowledge, skill, balance and insight. The lesson plans are designed to promote understanding of concepts rather than impart sheer bookish knowledge. Here again, an example of putting technology to use is Sri Sathya Sai Vidya Vahini, a novel programme which amalgamates web based technology, value based learning, secular curricula and teacher training.

Socicare - Love that transforms

'Love all, Serve all' is a dictum of Baba that is best demonstrated by the exemplary work that Sri Sathya Sai Organisations in India and Sai Organisations in over 120 other countries have been consistently performing. The four drinking water projects for example have directly benefitted over 11 million people in the water starved parts of Andhra Pradesh and Tamilnadu. Prompt and effective relief and support during disasters is another area where the contribution of Sai Organisations has been noteworthy.

**Other Independent Trusts**

Besides the above, the following four independent Trusts/Societies, function in Prasanthi Nilayam, and carry on charitable activities.

A. Sri Sathya Sai Sadhana Trust:

This religious Trust, registered in Bengaluru on 3rd October, 2008, carries on certain activities of public utility for serving devotees / visitors in Prasanthi Nilayam and Brindavan, Bengaluru through the following divisions:

i. Bhaktha Sahayak Division: provides food to the pilgrims through three canteens; maintains a Goshala; runs Prasanthi General Stores, where all basic necessities are available at modest prices; runs telephone booths etc.

ii. Mahila Division: provides training to ladies from rural areas for cooking, tailoring; provides fluoride-free filtered and processed clean drinking water to residents of Prasanthi Nilayam.

iii. Media Division: creates, edits/processes audio, visual and multimedia titles and documentaries covering all major religious celebrations as well as charitable activities taking place in Prasanthi Nilayam and brings out as CDs, DVDs etc of the events.

iv. Publications Division: prints, publishes and distributes books – spiritual, religious and other titles on Education in Human Values; prints and publishes monthly spiritual journal 'Sanathana Sarathi' in English and Telugu languages; runs a library and reading room.

v. Brindavan Bhaktha Sahayak Division: runs a canteen, a telephone booth, daily needs unit and a Goshala at Brindavan, Bengaluru.

B. Sri Sathya Sai Media Foundation:

The foundation, which started functioning in 2007-08, promotes, preserves, protects and disseminates

knowledge relating to philosophy, Indian culture and heritage and human values with special reference to the teachings of Baba.

C. Sri Sathya Sai Easwaramma Women's Welfare Trust:

The Trust provides antenatal & postnatal care to women, free of cost, in the villages surrounding Puttaparthi with the help of a fully equipped medical van. Around 130 villages are covered in the Puttaparthi, Bukkapatnam, Kothacheruvu and Nallamada mandals. The Trust has been registered under Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987.

D. Smt. Easwaramma Educational Society:

This society, formed in August 1972, has been running a Telugu medium high school for the last several years. An english medium school was started two years ago and is being run by the Society.

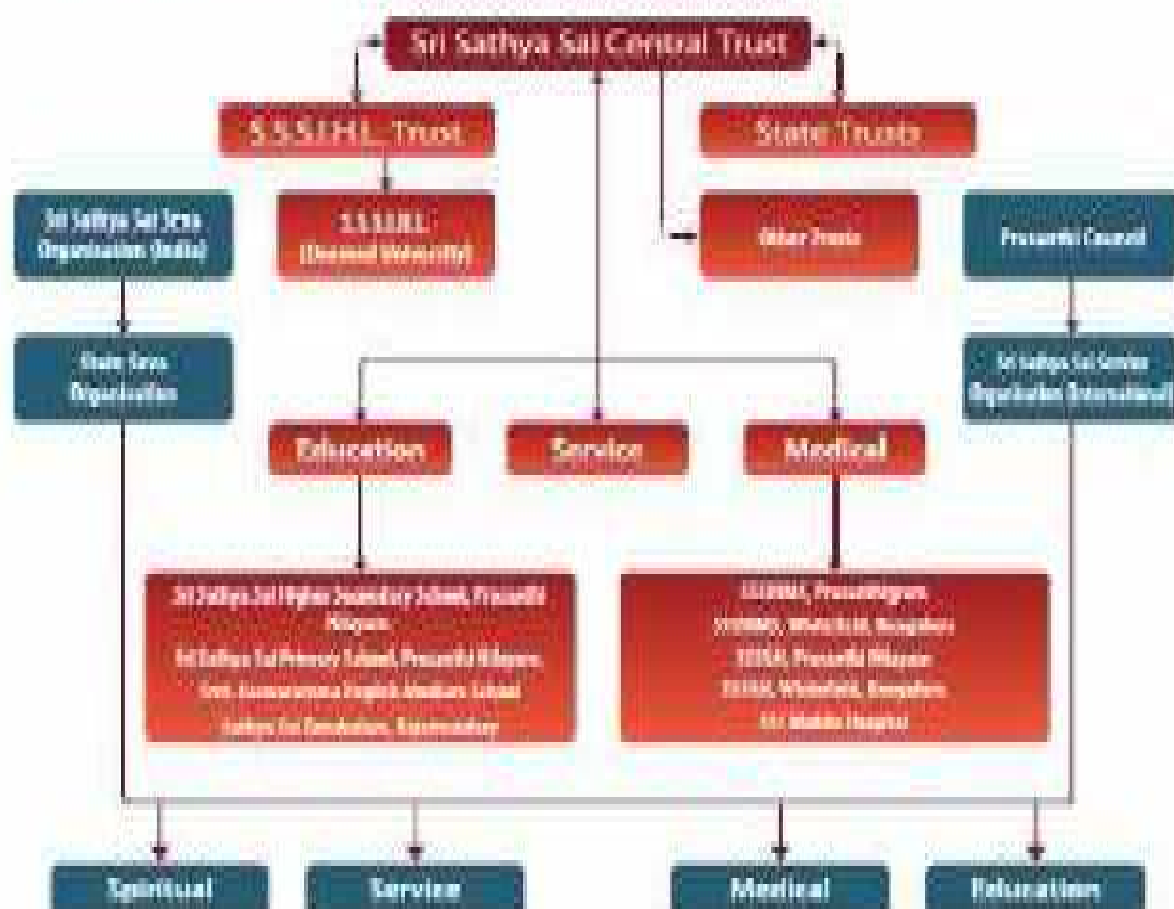
In several states, there are Trusts functioning under the name of "Sri Sathya Sai Trust (name of the State)".

Except four Trusts, the rest are independent Trusts and the Sri Sathya Sai Central Trust has no legal connection with them. In the case of the four Trusts in Bihar, Punjab, Himachal Pradesh and Haryana, the Sri Sathya Sai Central Trust has the power to nominate the Trustees.

There are some Sai Trusts and Foundations functioning abroad. They are totally independent bodies, founded by Baba. Sri Sathya Sai Central Trust has no legal connection with them.



Compliance & Social Impact

Compliance

Our books of accounts are regularly audited by an eminent firm of auditors. Sri Sathya Sai Central Trust has consistently adhered to procedures of regulatory compliance required by various departments of the government. The Trust files income tax returns every year, and responds promptly to any follow-up queries by the Income Tax Department. Reports required under Foreign Contribution Regulation Act, 1976 are regularly submitted to the Ministry of Home Affairs, Government of India. The Trust has been filing a copy of the annual financial statements along with a statement giving details of additions/ deletions to the assets of the Trust, with the Assistant Commissioner of Endowments, Anantapur every year as per subsection 10 of section 43 of the Andhra Pradesh Catholic and Hindu Religious Institutions and Endowments Act, 1987. The Trust has been prompt and timely in its history of compliance.

Social Impact

The Anantapur Water Supply Project has had the distinction of being mentioned in the Ninth Five Year Plan as a project that is worthy of emulation. The fourth World Water Forum held in Mexico in March 2006, adjudged Anantapur Water Project as one of the ten best "Local Action Projects" in the world contributing to the "Millennium Development Goals".

The value of the projects executed by the Trust and transferred to the Government and public so far, in the area of drinking water supply alone, is around Rs. 500 Crore. The Trust is currently engaged in extension of this project to cover additional 118 habitations at a cost of Rs 75 Crores.

The Trust has also been running two general hospitals - one at Puttaparthi and another at Whitefield - Bengaluru and two Super Specialty Hospitals - one at Prasantigram and another at Whitefield, offering free medical care for certain specialties. It can be safely estimated that the two super-specialty hospitals alone, since inception have offered medical services worth at least Rs 3,200 crores completely free of cost.
